COMES NOW the State of Colorado and provides the following status report to the Special Master pursuant to paragraph 5 of the Case Management Plan.

This is the second status report from Colorado. On May 21, 2018, Colorado filed a motion to approve the Non-Waiver Agreement executed by all the parties in this original action. That motion remains pending. On July 20 and 23, 2018, Texas and the United States, respectively, filed responsive pleadings to New Mexico's counterclaims. The parties have a hearing scheduled with the Special Master on August 28, 2018 at which they may discuss anticipated discovery needs and pre-trial scheduling. Initial disclosures are due from the parties on August 30, 2018. As related to this litigation, Colorado does not currently have the information needed to either construct its own computer model or evaluate models created by the other parties.
