STATE OF NEW MEXICO'S MOTION TO AMEND TRIAL MANAGEMENT SCHEDULE ALLOWING NEW MEXICO TO DEPOSE WITNESSES FOR UNITED STATES INTERNATIONAL BOUNDARY AND WATER COMMISSION FOLLOWING CLOSE OF DISCOVERY AND TO FILE DISPOSITIVE MOTIONS INCORPORATING <u>SUCH TESTIMONY AFTER DISPOSITIVE MOTIONS DEADLINE</u>

The State of New Mexico ("New Mexico") moves to extend certain case management deadlines so it can depose witnesses for the International Boundary and Water Commission ("IBWC") and incorporate their testimony in dispositive motions where pertinent. In further support of this Motion, New Mexico states as follows:

I. INTRODUCTION AND SUMMARY OF ARGUMENTS

Pursuant to the Trial Management Schedule ("Scheduling Order") of May 5, 2020, the Parties are to complete discovery by August 31, 2020, and to file any dispositive motions by October 15, 2020. [Doc. 351]. However, to date, the United States ("U.S.") has failed to provide New Mexico with all electronically stored information ("ESI") from the IBWC that is responsive to New Mexico's requests for documents concerning that agency. Indeed, the U.S. advised New Mexico last Friday that it is in the process of finalizing another round of ESI production from the IBWC that could top 40,000 documents. *See* Exhibit ("Exh.") A, Email from Lee Leininger to Shelly Dalrymple, July 17, 2020, 3:55 PM (noting that: "We are currently preparing another production that will likely add another 30-40,000 documents to our initial IBWC production [of July 15, 2020].").

The U.S. produced its first and only set of ESI from the IBWC on July 15, 2020. *See* Exh. B, U.S.'s Notice of Fifth Supplemental Production of Electronically Stored Information, dated July 15, 2020. That initial set, which consists of 29,102 separate documents totaling over 96,000 pages of information, is so voluminous that New Mexico cannot conduct a timely review of the documents before the close of discovery. *See* Exh. A at 2, Email from Shelly Dalyrmple to Lee Leininger and James Dubois, July 16, 2020, 8:11 AM (noting that "Thirty thousand documents presents an enormous problem for New Mexico to review, digest, and prepare for any necessary

discovery as to the facts in these documents, not to mention mining them for information for the four pending depositions I have requested of the United States.").

The Parties have an obligation of diligence with respect to the production of ESI. *See* Stipulation for the Production of Documents and Electronically Stored Information ("ESI"), November 14, 2018, [Doc. 142 at ¶ 12(b)] (mandating that, if a particular production request ("RFP") requires an additional electronic search of custodians, locations and sources for responsive email ESI, a Party receiving such an RFP confer with a Requesting Party within a set period of days and provide its proposed search terms, custodians and locations "in order to meet its obligation of diligence").

As detailed more fully below, New Mexico has made a good faith effort to confer with the U.S. where the U.S. has proposed modified search terms for identifying ESI that would meet its obligations under the ESI Stipulation. *See id.* at \P 12 ("If the requesting Party . . . objects to some or all of the proposed search protocol, the Parties must confer within seven (7) days of receipt of the information provided."); and at \P 19 ("Discovery Disputes. Before filing any motion with the Special Master regarding electronic discovery or evidence, the Parties shall meet and confer in a good faith attempt to resolve such disputes, in accordance with CMP section 12.").

Despite these efforts, the U.S. has failed to meet its discovery obligations to: (1) fully meet its obligations under the ESI Stipulation; (2) timely confer with New Mexico on proposed modifications to search terms for collecting and culling ESI; and (3) produce responsive ESI for review within the time frame set for completion of all discovery, which includes depositions.

Given the volume of material produced in the U.S.'s initial production set of ESI for the IBWC, and the expected volume of the final ESI production set for this agency, two facts are clear. First, New Mexico cannot possibly review the production in time to depose any IBWC witnesses on these documents before the close of discovery. The production is not even complete yet and what has been produced thus far is so unmanageable in sheer volume as to constitute a "data dump". Second, New Mexico will be effectively precluded from using the IBWC production in dispositive motions given that the deadline for filing such motions expires on October 15, 2020.

There is no need to engage in any lengthy argument on these points. The Scheduling Order allows little time between the deadline for the close of discovery and the deadline for submission of dispositive motions, which the Special Master has acknowledged. *See* [Doc. 351 at 1] ("Attached as Exhibit A is an Amended Trial Management Schedule in this case. Given the amount of discovery left to be accomplished, and the set the completion of discovery for August 31, 2020. That *will not leave a lot of time between the end of discovery and filing of dispositive motions.*") (emphasis added). In setting these deadlines, the Special Master has assumed the Parties will not be precluded from working on dispositive motions well in advance of the completion of discovery. *See id.* ("However, *I assume the parties can begin working on dispositive motions well in advance of the completion of discovery.*") (emphasis added). Obviously, this assumption doesn't work for New Mexico if the U.S. hasn't even provided all ESI from the IBWC that is responsive to New Mexico's production requests.

With discovery closing in roughly thirty (30) days, the U.S.'s failure to produce all ESI from the IBWC in accordance with its ESI Stipulation obligations severely hampers New Mexico's ability to prosecute its case. As the Special Master has noted:

In simple terms, *this case is a dispute about where the waters of the Rio Grande have been going*, where they should have been going, and where they should go in the future. *Texas alleges New Mexico improperly has been taking more* surface water, hydrologically connected groundwater, and return flows between the Elephant Butte Dam and Texas *than allowed by the Rio Grande Compact...* New Mexico asserts similar but geographically distinct claims against Texas and *also alleges unaccounted-for Texan and Mexican water capture is at least partially to blame for any alleged shortages experienced by Texas.*

See [Doc. 340 at 1-2] (emphasis added).

Obtaining ESI on how the IBWC has regulated the distribution of the waters of the Rio Grande and on factors that could affect "where the waters of the Rio Grande have been going" is critical for New Mexico's defense. And New Mexico's requests for production of ESI bearing on such matters is likely to lead to the discovery of admissible evidence because the IBWC is tasked with, inter alia:

Apply[ing] the rights and obligations which the Governments of the United States and Mexico assume under the numerous boundary and water treaties and related agreements...

As provided for in the treaties and agreements, those rights and obligations include: distribution between the two countries of the waters of the Rio Grande and of the Colorado River; . . .

In addition to cooperative projects undertaken to implement existing treaties and international agreements, the U.S. and Mexican Commissioners make recommendations to their respective Governments for resolution of new or anticipated boundary or water problems...

See "About Us" page on IBWC website, "The International Boundary and Water Commission -

Its Mission, Organization and Procedures for Solution of Boundary and Water Problems",

available at, https://www.ibwc.gov/About_Us/About_Us.html.

In short, New Mexico submits there is good cause to amend the Scheduling Order to ensure

that: (1) New Mexico receives all ESI that is responsive to its production requests by a fixed date;

(2) has a reasonable opportunity to depose IBWC witnesses on information obtained through such

production: and (3) has a reasonable opportunity to incorporate discoverable information on the

IBWC into dispositive motions where useful. New Mexico sought the U.S.'s concurrence on this

Motion prior to filing it. See Exh. C, Email from Shelly Dalrymple to Lee Leininger, July 22, 2020.

Counsel for the U.S. opposes this Motion.

II. RELEVANT FACTS AND PROCEDURAL HISTORY

1. Counsel for New Mexico, Texas, the U.S., and Colorado (the "Parties") negotiated the terms of the Parties' Stipulation Regarding Procedure for Production of Documents and Electronically Stored Information (ESI) ("ESI Stipulation"), filed November 14, 2018. [Doc. 142].

2. A key provision of the ESI Stipulation required that the Parties "[C]onfer and agree upon search terms and protocols for each Party's broadly-based search across all potentially relevant custodians, locations, and Sources, with the intent that each Party collect, review, and produce all discoverable Documents and ESI relevant to the claims, defenses, and disputed facts alleged with particularity in the pleadings." [*Id.* at ¶ 12(a)].

3. In late June 2019, the Parties reached an agreement on a list of approximately 418 search "strings" and collection protocols to be applied in responding to production requests (the "Agreed Terms"). *See* Exh. D, Email from Christine Garro, counsel for Texas, to counsel for New Mexico, U.S. and Colorado, June 19, 2019 (memorializing issues discussed by the Parties relating to ESI searches and protocols and noting that Texas, New Mexico and the U.S. agreed to use a consolidated search terms list, and to modify the list only when search syntax/connectors require it based and depending on software searching capabilities."); *see also* Exh. E, "Comparison of Proposed ESI Search Terms," (showing 418 Agreed Terms, where column A (furthest left), lists final Agreed Terms, and columns B (middle)¹ and C (left) reflect, respectively, geographic limiters to be included at the request of the U.S. (middle), and the U.S.'s explanation for the geographic limiter). (For purposes of this Fact, the green and yellow highlighting should be ignored.)

¹ For purposes of this Fact, the highlighting shown on Exh. E is not relevant and should be ignored.

4. Additionally, New Mexico and Texas took the position that the Parties should run a broad search of the ESI first and follow that up with "additional searches within the resulting materials to cull the documents and materials to a set likely to be rich in potentially responsive/relevant documents, data, etc." *Id*.

5. The Parties engaged in regular status conferences to discuss discovery issues. *See* Exh. F, Email from Shelly Dalrymple, Nov. 18, 2019, at 1 (Subject: TX. V. NM – Biweekly Discovery Calls).

6. Although Texas was able to make one ESI production in October, ostensibly using the Agreed Terms, some four (4) months later on November 14, 2019, the U.S. proposed modifications to the Agreed Terms. *Id.* at 2, Email from Lee Leininger, Nov. 14, 2019 (advising the prior list of Agreed Terms had yielded an inordinate number of non-responsive documents and stating the U.S. believes it has uncovered all broad search and syntax problems that produced this result and proposing a new search list to correct for such errors going forward).

7. New Mexico advised it would consider the proposed modification, but noted that, in the meantime, the Parties had committed to perform the necessary searches or initial ESI "pulls" using the Agreed Terms, and to deal with any anomalous results or redundancies during the internal review process. *Id.* at 1, Email from Shelly Dalrymple, Nov. 18, 2019.

8. New Mexico advised it was continuing to use the Agreed Terms for initial ESI searches and to review the resultant "hits" for responsiveness internally and to get production out to the requesting parties on a rolling basis. *Id*.

9. New Mexico stated it needed rolling production of ESI from the other Parties as quickly as possible. *Id*.

10. At no time during the Parties' regular discovery conference calls did the U.S. advise New Mexico it would be able to complete ESI production of IBWC records by the then-operative May 31, 2020 discovery deadline.

11. On March 18, 2020, the U.S. advised the Parties on the status of its ESI searches of Bureau of Reclamation ("BOR") and IBWC databases. Specifically, the U.S. advised it expected it would complete production of the BOR ESI by the end of March, and had obtained over 15,000 documents in its initial search of IBWC files. *See* Exh. G, Email from Lee Leininger, March 18, 2020. Given the enormous numbers of documents the Agreed Terms were returning for all Parties, these comments from the U.S. were not concerning in terms of the U.S. meeting the May 31, 2020 discovery deadline.

12. The U.S. also advised that: "The production of ESI from IBWC would take longer [than BOR]. We *do not have a target date for* IBWC ESI *final production*..." However, the U.S. assured the Parties that "*we will be rolling out those documents as our batch review are completed*." *Id.* (emphasis added).

13. By way of comparison, New Mexico had filed its Eighth and Ninth Notices of Supplemental Production as of March 9, 2020. *See id.* at 2-3, Email from Michael Kopp, forwarding Notices.

14. From March 18, 2020, forward until the present, whether in the course of discovery conferences with the Parties or status conferences with the Special Master, the U.S. never mentioned that it was facing any unexpected issues that would impact its ability to complete rolling production of the ESI from the IBWC by the close of discovery. *See* Transcripts of Status Hearings from May 15, 2020, May 29, 2020, and June 12, 2020 (generally).

15. On April 1, 2020, the Special Master imposed a stay on depositions, citing concerns over COVID-19, but clarified that the stay did not apply to other discovery. *See* Order of April 1, 2020 [Doc. 339 at 1].

16. On May 5, 2020, the Special Master ordered that the stay on depositions would be lifted on May 18, 2020, and extended the deadline for completion of discovery to August 31, 2020. *See* Order of May 5, 2020 [Doc. 339 at 2].

17. On May 14, 2020, New Mexico asked the U.S. to provide dates when four (4) IBWC witnesses could appear for a deposition, anticipating that the U.S. would be ready to produce ESI from the IBWC given that the Special Master had only just extended discovery past May 31st. *See* Exh. H, Email from Shelly Dalrymple, May 14, 2020, at 1 and at 2 (proposing various dates at the end of June and July and at the beginning of August for deposing IBWC witnesses: Wayne Treers, Carolyn Donnely, Filiberto Cortez, and former IBWC employee Ed Drusina [sp.]).

New Mexico scheduled a telephone conference among the Parties for June 3, 2020,
 in order to discuss outstanding discovery issues.

19. On June 2, 2020, the U.S. notified the Parties that it had "run into a production problem with the IBWC electronically stored information (ESI)... the search returned hundreds of thousands of documents...". *See* Exh. I, Email from Lee Leininger, June 2, 2020.

20. More specifically, the U.S. advised that the searches it ran using its revision to the Agreed Terms had produced more than 400,000 documents, the vast majority of which appeared to be non-responsive when they were subject to internal review. *Id.* at 1.

21. The U.S. advised that it had consulted with IBWC's counsel and record custodians on how to refine the ESI search of that agency's records to yield more responsive documents

concentrating on four discrete subject areas: (1) documents on Rio Grande channel maintenance; (2) documents on Mexico's use of Rio Grande Project/Treaty water; (3) documents on Mexico's groundwater pumping within the Mesilla or Hueco basins; and (4) the 2008 Operating Agreement. *Id.* at 2. Based on its decision of the relevant subject areas, the U.S. provided thirty (30) new searches and reported that this search had still returned "tens of thousands" of documents, which the U.S. was currently reviewing and would be producing shortly, and asked that the Parties discuss this more "focused" search procedure the U.S. had implemented and any objections the Parties might have at their upcoming discovery conference. *Id.* at 3.

22. Of the thirty (30) new search strings, nineteen (19) contained words not in the Agreed Terms.

23. The following day, during the Parties' regularly scheduled discovery teleconference, New Mexico notified the U.S. that it was surprised the U.S. would devise new ESI search terms and apply them to the IBWC records without conferring with New Mexico and New Mexico would need time to review the situation and would likely object.

24. New Mexico then engaged in a detailed analysis of the 400 Agreed Terms, evaluating what terms were essential in order to meet its discovery needs specific to the IBWC. New Mexico engaged in good faith communications with the U.S. during this process. During these communications, the U.S. admitted the thirty search terms it proposed on June 2nd would actually only be run against the collection of IBWC documents *it had already collected* through the application of the Agreed Terms to the IBWC personnel. (Thus, the new terms would only have captured a portion of the documents relevant to the U.S.'s *new* terms, depriving New Mexico of a fully responsive production.) On June 23, 2020, New Mexico advised the U.S. that it had been able to reduce the Agreed Terms by approximately one-half to streamline the ESI search of

the IBWC records. *See id.* at 1, Email from Shelly Dalrymple, June 27, 2020, at ¶ 1 (describing modified search terms list New Mexico provided to the U.S. on June 23, 2020); *see also* Exh. E (where green highlighting marks search terms in the original Agreed Terms list that New Mexico would retain, i.e., the modified list). In providing the concessions to the U.S., New Mexico reiterated that it would have to receive the pertinent ESI from the IBWC no later than July 15 in order to be able to review the material before the close of discovery.

25. The Parties agreed to discuss New Mexico's concessions on the ESI search terms, as well as other discovery issues, on June 26, 2020. *See* Exh. I at 1, Email from Shelly Dalrymple, June 27, 2020, at ¶ 1 (memorializing agreement to discuss New Mexico's modified list of ESI search terms).

26. On June 26, 2020, the U.S. advised that it would provide its comments on New Mexico's proposed modifications by June 29, 2020. The U.S. further stated it would provide data on the number of "hits" its list of targeted search terms were generating. *See id.* at \P 3.

27. New Mexico reiterated that in order to complete its discovery of the IBWC by the August 31^{st} deadline for close of discovery, it would have to receive responsibly culled IBWC ESI production no later than July 15^{th} . *See id.* at ¶ 4.

28. The U.S. did not provide any feedback on New Mexico's proposed concessions to the U.S.'s ESI search problem until July 1, 2020. *See* Exh. J, Email from Lee Leininger, July 1, 2020.

29. The U.S. proposed further modifications, but did not provide any update on the number of documents that were being generated as a result of its proposed modifications. *See id.*

30. New Mexico analyzed the latest modifications that the U.S. proposed and on July 5, 2020 New Mexico responded with additional concessions. *See* Exh. K, Email from Shelly Dalyrmple, July 5, 2020.

31. The U.S. proposed two (2) further rounds of modifications to the Agreed Terms and on July 8, 2020, it advised that it would rerun the searches based on the most recent modifications (concessions) and would produce the ESI from the IBWC "on or before July 15." *See* Exh. L, Email from Lee Leininger, July 8, 2020 (highlights reflecting responses to Email by Shelly Dalrymple on July 9, confirming final concessions by New Mexico).

32. The U.S. has never provided an estimate of the volume of documents that would be generated as a result of these repeated modifications to the Agreed Terms.

33. New Mexico reasonably expected the modifications would, at a minimum, reduce the number of responsive documents from the "tens of thousands" of documents the U.S. reported its first "targeted" search had returned on June 2, 2020. *See* Exh. I at 3; *supra*, Relevant Facts at ¶ 21 ("This new [targeted] search has still generated tens of thousands of documents which we will be producing soon.").

34. In anticipation of receiving the first and final set of ESI documents from the IBWC on July 15, 2020, New Mexico attempted to schedule depositions of the IBWC witnesses it had identified previously. *See* Exh. M, Email from Shelly Dalrymple, July 13, 2020, at 2; *see also* Exh. H at 2 and *supra*, Relevant Facts at ¶ 17 (providing names of four (4) IBWC witness that New Mexico would like to depose and proposing dates for the depositions in late June, late July and the first week of August).

35. On July 15, 2020, New Mexico followed up on its request to schedule depositions of IBWC witnesses, and also asked the U.S. whether it would be producing a full and final set of

all responsive ESI from the IBWC later that day or would be producing the ESI in a series of rolling productions. *See* Exh. M, Email from Shelly Dalrymple, July 15, 2020, at 1, Email at 2:23 PM (on depositions), and Email of 5:41 PM (on ESI production).

36. The U.S. did not respond other than to confirm it would be producing the ESI that evening. *See id.* at 1, Email from Lee Leininger at July 15, 2020 at 5:19 PM.

37. On the evening of July 15, 2020, the U.S. served notice that it had uploaded 29,120 documents totaling 96,392 pages of ESI information from the IBW. *See* Exh. B at 1.

38. New Mexico immediately notified the U.S. that it was surprised at the volume of documents. New Mexico also informed the U.S. that New Mexico could not promptly sample the production to determine responsiveness because of the technical processes of moving the electronic files from the site where the U.S. uploads them to the site where New Mexico can access them (Veritext) and unzip the files. New Mexico asked that the U.S. contact New Mexico forthwith to discuss these matters. *See* Exh. N, Email from Shelly Dalrymple, July 16, 2020.

39. On the afternoon of July 17, 2020, the U.S. responded by email advising that it was reviewing additional ESI that generated during the last round of searches and would be rolling out another set of responsive documents that could equal or exceed the initial production. *See* Exh. A, Email from Lee Leininger, July 17, 2020 (advising the next ESI production set could consist of an additional 30,000-40,000 documents).

40. The U.S. did not provide any details on when this second ESI production set might be forthcoming. *See id*.

41. New Mexico requested that the U.S. discuss this matter with New Mexico via conference call, advising that New Mexico would have no option but to seek relief from the Special Master if the U.S. did not fulfill its discovery obligations. Despite repeated requests for a telephone

call as to the requested depositions and the problems resulting from the U.S.'s IBWC's ESI production, the U.S. did not communicate on the issue until New Mexico scheduled an all-parties discovery call on July 22, 2020.

III. APPLICABLE LEGAL STANDARDS

Federal Rule of Civil Procedure 16(b)(4) ("Rule 16") articulates the primary standard for modifying a scheduling order, to wit: "good cause." In addition, subpart 'd' of Rule 16 states that the pretrial order "controls the course of the action unless the court modifies it." *Id*. As the Eighth Circuit has explained, the Rule 16(b)

The Eighth Circuit has explained the Rule 16(b) "good cause" standard as follows: "The primary measure of good cause is the movant's diligence in attempting to meet the order's requirements." *Rahn v. Hawkins*, 464 F.3d 813, 822 (8th Cir. 2006); *see also Sherman v. Winco Fireworks, Inc.*, 532 F.3d 709, 717 (8th Cir. 2008) ("Our cases reviewing Rule 16(b) rulings focus in the first instance (and usually solely) on the diligence of the party who sought modification of the order."); Fed.R.Civ.P. 16(b), advisory committee note (1983 Amendment) ("[T]he court may modify the schedule on a showing of good cause if it cannot reasonably be met despite the diligence of the party seeking the extension.").

Although other factors may be considered, the general consensus across the federal circuits² and federal district courts is that the inquiry turns mainly on whether the movant was

² But *see Marcilis v. Twp. of Redford*, 693 F.3d 589, 597 (6th Cir. 2012) ("A court asked to modify a scheduling order for good cause 'may do so only if [a deadline] cannot reasonably be met despite the diligence of the party seeking the extension.' " but noting another "important consideration for a district court deciding whether Rule 16s good cause standard is met is whether the opposing party will suffer prejudice by virtue of the amendment.' ")(internal citations omitted); *Meaux Surface Protection, Inc. v. Fogleman*, 607 F.3d 161, 167 (5th Cir. 2010) (listing four factors that bear on the good cause analysis including: four relevant factors to consider when determining whether there is good cause under Rule 16(b)(4): "(1) the explanation for the failure to timely [comply with the scheduling order]; (2) the importance of the [modification]; (3)

diligent in attempting to meet the court's order. See Holmes v. Grubman, 568 F.3d 329, 335 (2d Cir. 2009) ("Whether good cause exists turns on the 'diligence of the moving party.' ") (internal citation omitted); Cook v. Howard, 484 F. App'x 805, 815 (4th Cir. 2012) ("Good cause" requires 'the party seeking relief [to] show that the deadlines cannot reasonably be met despite the party's diligence," and whatever other factors are also considered, "the good-cause standard will not be satisfied if the [district] court concludes that the party seeking relief (or that party's attorney) has not acted diligently in compliance with the schedule.""); Squyres v. Heico Companies, L.L.C., 782 F.3d 224, 237 (5th Cir. 2015) ("To show good cause, the party seeking to modify the scheduling order has the burden of showing 'that the deadlines cannot reasonably be met despite the diligence of the party needing the extension."") (internal citation omitted); Johnson v. Mammoth Recreations, Inc., 975 F.2d 604, 609 (9th Cir. 1992) (noting the focus of the good cause inquiry is upon the "moving party's reasons for seeking the modification" and "if that party was not diligent, the inquiry should end."); see also 6A Charles Alan Wright, Arthur R. Miller, and Mary Kay Kane, Federal Practice and Procedure Civ.3d § 1522.2 (3d ed. 2010) (collecting cases); and 3 Moores Federal Practice § 15.14[1] [b], at 16-72 (Matthew Bender 3d ed. 2010) ("[A]lthough undoubtedly there are differences of views among district judges about how compelling a showing must be to justify extending the deadlines set in scheduling orders, it seems clear that the factor on which courts are most likely to focus when making this determination is the relative diligence of the lawyer or lawyers who seek the change.").

Federal courts have also identified various factors to be evaluated when considering a motion to extend or reopen discovery: 1) whether trial is imminent, 2) whether the request is

potential prejudice in allowing the [modification]; and (4) the availability of a continuance to cure such prejudice."

opposed, 3) whether the non-moving party would be prejudiced, 4) whether the moving party was diligent in obtaining discovery within the guidelines established by the court, 5) the foreseeability of the need for additional discovery in light of the time allowed for discovery . . . , and 6) the likelihood that the discovery will lead to relevant evidence. *See Howze v. Jones & Laughlin Steel Corp.*, 750 F.2d 1208, 1213 (3d Cir. 1984); *Wilk v. Am. Med. Assoc.*, 719 F.2d 207, 232 (7th Cir. 1983), *cert. denied* 467 U.S. 1210 (1984); *Geremia v. First Nat'l Bank of Boston*, 653 F.2d 1, 5-6 (1st Cir. 1981)).

In any case, when a court is asked to apply the Federal Rules of Civil Procedure, it must be mindful that the Rules must be "construed and administered to secure the just, speedy, and inexpensive determination of every action." Fed.R.Civ.P. 1.

IV. ARGUMENT

The facts set forth in Section II of this Motion demonstrate there is good cause to grant New Mexico the relief it is seeking in this Motion. To reiterate, New Mexico is seeking an extension of the deadlines to complete discovery and to file dispositive motions so it can depose IBWC witnesses and incorporate their testimony in dispositive motions if needed. New Mexico is not seeking a general extension to complete discovery to any parties other than the U.S. or on any issues other than involving New Mexico's production requests for ESI from IBWC records. The facts establish that New Mexico cannot depose IBWC witnesses before the close of discovery on August 31, 2020, and this is not due to any lack of diligence on New Mexico's part.

Indeed, the facts show New Mexico has been very diligent in following up on ESI production requests to the U.S. for IBWC records and in trying to schedule depositions of IBWC witnesses in a timely manner. *See* Relevant Facts in Section II of this Motion ("Facts") at ¶¶ 3-9, 15-17, 18, 23-30, 31, 37, 39.. The facts also show New Mexico has been diligent in complying

with its discovery obligations to timely produce and seasonally supplement its production of ESI in response to RFPs from other Parties. *Id.* at ¶ 13. New Mexico's discovery obligations include the duty to confer with counsel for the U.S. on discovery disputes, and in particular on proposals to modify ESI search terms and disputes arising over electronic discovery. *See id.* at ¶¶ 1-2; and *supra*, Introduction at 2 (citing to ESI Stipulation [Doc. 142 at, respectively, ¶ 12(b); at ¶ 12, at ¶ 19]. There is no question but that New Mexico has conferred with the U.S. whenever the U.S. has asked to modify ESI search terms in an effort to streamline the production of ESI and resolve matters without motions practice. *See* Facts at ¶¶ 6-7, 19, 21-26, 29-31, 38, 41.

New Mexico has the right to expect that the U.S., for its part, would be equally diligent in meeting its discovery obligations to New Mexico. The U.S. is one of the signatories to the ESI Stipulation and, as a Party to this action, it has discovery obligations under Rule 37 and CMP section 12. Those obligations include: diligently keeping New Mexico apprised of problems with ESI searches and collection; conferring in good faith on proposed modifications to ESI search terms and not simply advising of modifications after-the-fact; producing documents that are responsive to New Mexico's RFPs on IBWC records; and responding to requests to schedule depositions in a timely manner. Unfortunately, the U.S. has not always met these obligations to New Mexico. *See* Facts at ¶ 10-12, 14, 17-19, 24, 26, 28-29, 31-32, 35-36, 37, 39-41.

As a result of the U.S.'s failure to timely and fully produce all ESI from the IBWC that is responsive to New Mexico's RFPs, New Mexico is severely hampered in moving forward with other forms of discovery. New Mexico cannot begin to depose IBWC witnesses on the ESI information until it has all the relevant information in hand. Additionally, New Mexico will be deprived of meaningful use of the ESI if the U.S. has not conducted a review of the material generated in the ESI searches to cull any non-responsive material. *See id.* at ¶¶ 4, 8, 27. Judging

by the volume of the initial set of ESI documents that the U.S. produced from its searches of IBWC records, the U.S. has not conducted the proper internal review of these documents that is needed to cull extraneous material.

The facts indicate it was not foreseeable to New Mexico that the ESI production from the searches of IBWC records would be so voluminous. The U.S. represented the "focused" search modification it proposed on June 2, 2020, had reduced the number of hits from hundreds of thousands to tens of thousands of documents. *Compare id.* at \P 20 *with* \P 21. Additionally, the U.S. repeatedly represented that it was in the process of conducting "batch reviews" of the material collected from searches or was reviewing the material that was generated following modifications to the search terms. *See id.* at $\P\P$ 12, 21. Such representations suggest the U.S. was conducting the type of internal New Mexico and other Parties had agreed was essential in producing ESI. *See id.* at $\P\P$ 4, 7-8. And to the extent this was not the procedure the U.S. had agreed to follow, it never attempted to correct any misapprehension New Mexico might have on the matter. See, e.g., *id.* at \P 27, wherein New Mexico states it is expecting the U.S. to responsibly cull the materials obtained in the ESI searches before the producing them.

In sum, the facts show that New Mexico did not receive *any* ESI in response to its RFPs for IBWC records until last Wednesday, July 15, 2020, and it still has not received *all* of the responsive ESI. New Mexico should not have to forego its right to depose IBWC witnesses as part of discovery simply because the U.S. was not able to provide the ESI that is responsive to New Mexico's production requests before now. Nor should New Mexico be deprived of the opportunity to use the ESI documents and any IBWC witness testimony on information contained therein in dispositive motions. As New Mexico has noted previously, discovery of this information from the IBWC is critical to New Mexico's ability to defend itself in this litigation. *See supra*,

Introduction at 2-3 (quoting from [Doc. 340 at 3-4] ("In simple terms, *this case is a dispute about where the waters of the Rio Grande have been going*, where they should have been going, and where they should go in the future.") (emphasis added) and at 4 (discussing the responsibilities of the IBWC for regulating where the Rio Grande waters go and for recommending solutions to resolve new and anticipated problems with those waters).

The only way to correct the impending prejudice to New Mexico is to grant New Mexico's Motion to Amend the Scheduling Order so New Mexico can: (1) depose IBWC witnesses following the close of discovery; and (2) file any dispositive motions or responses to dispositive motions that are supported by testimony obtained in these depositions. Of course, before New Mexico can depose IBWC witnesses, it needs to review all the ESI that is responsive to its RFPs for IBWC records. But it is not yet in receipt of all of those records. In fact, it appears it may have only fifty (50) percent of the records that the U.S has collected in its ESI searches and identified as responsive. Additionally, New Mexico will require the U.S.'s cooperate in scheduling depositions of IBWC witnesses. Otherwise, granting New Mexico an extension of the discovery deadline and dispositive motions will be not have its desired effect. Because the U.S. has not been able to commit to production of the remaining ESI records by a date certain, or to schedule depositions of IBWC witnesses, the Special Master will need to order the U.S. to do so.

In view of these facts, New Mexico asks that the Special Master grant this Motion for the limited purpose described above and to enter certain prefatory orders to ensure the relief sought will be effective. More specifically, as a prefatory matter, New Mexico asks that the Special Master order the U.S. to roll out its final production of IBWC ESI by no later than August 15. New Mexico also asks that the Special Master order the U.S. to work with New Mexico in the interim to make sure the initial ESI production set is subject to any additional review that

might be needed to cull non-responsive documents. Lastly, New Mexico asks that the Special Master order the U.S. to confer with New Mexico on the scheduling of depositions for IBWC witnesses and commit to deposition dates **by August 15.** There can be no prejudice to the U.S. in ordering it to comply with discovery obligations.

If the Special Master enters these orders to ensure that New Mexico can move forward with depositions of IBWC witnesses, New Mexico can be ready to depose all IBWC witnesses identified thus far and any 30(b)(6) witnesses **within ninety (90) days of the close of discovery**. New Mexico believes this time frame for completion of depositions is reasonable given the expected volume of the final ESI production set. New Mexico also believes it can incorporate any potentially dispositive information that might be obtained from these witnesses into dispositive motions by December 21st. The current Scheduling Order sets December 21st as the deadline for submission of reply briefs to dispositive motions. [Doc. 351]. However, if the Scheduling Order can be amended to set an expedited briefing schedule for any dispositive motions that New Mexico might file based on IBWC discovery, there is no reason any other pretrial deadlines need be effected. For example, the Special Master could set a single deadline in late January of 2021 by which all briefing on such dispositive motions would have to be completed, allowing a minimum of fifteen (15) days for filing response briefs and reply briefs.

There is good cause to grant this Motion under the standards that govern motion to amend scheduling orders because New Mexico has been diligent in meeting discovery and should not be prejudiced from availing itself of discovery due to factors outside its control. Likewise, the standards that factor into evaluating motions to extend discovery weigh in favor of granting New Mexico relief. Trial is not imminent; it is not scheduled until May/June of 2021. [Doc 351]. The extensions proposed above need not impact any case management deadlines in the Scheduling

Order that arise after the end of this year and the conclusion of briefing on dispositive motions. The proposed extension works no discernible prejudice on the U.S. It is simply being held to fulfillment of its discovery obligations. New Mexico has been diligent in obtaining discovery within the guidelines established in the Scheduling Order and should be entitled to expect the U.S. would be meet its obligation of diligence with respect to production of the IBWC ESI. Lastly, the requested relief is very likely to lead to the discovery of admissible evidence as to "where the waters of the Rio Grande have been going" based on information collected by one of the agencies tasked with regulating the movement of those waters.

WHEREFORE, New Mexico hereby requests the Court enter an Order that provides the following:

A. Grants' New Mexico's Motion to Amend Trial Management Schedule Allowing New Mexico to Depose Witnesses for United States International Boundary And Water Commission Following Close of Discovery and to File Dispositive Motions Incorporating Such Testimony After Dispositive Motions Deadline;

B. Extends the deadline for New Mexico to complete deposition of IBCW witnesses by 90 days from the close of discovery;

C. The U.S. shall roll out its final production of IBWC ESI by no later than August 15, 2020;

D. The U.S. shall work with New Mexico between now and August 15, 2020, to conduct any additional review that might be needed to cull non-responsive documents from any IBWC documents produced thus far or that remain to be produced;

E. The U.S. shall confer with New Mexico on the scheduling of depositions for IBWC witnesses and shall commit to deposition dates by August 15, 2020;

F. Extends the corresponding deadline for New Mexico to file any dispositive motions

relating to IBWC from October 15, 2020 to December 21, 2020, and all briefing should be

complete by January 21, 2021;

G. Awards New Mexico reasonable fees and costs in bringing this Motion forward;

and

H. Awards New Mexico any and all other relief deemed proper.

Shelly – We did accommodate New Mexico's demands for ESI from the International Boundary Waters Commission (IBWC). Unfortunately, our effort to limit production to a much smaller document set better related to the issues of the case was rejected, and you insisted on a production of documents that were generated by the ESI list. Please recall that we informed you months ago that the list of 429 ESI search term combinations negotiated by the Parties in June 2019, and then corrected for errors in November 2019 but still containing nearly 400 separate search combinations, was a problem when applied to IBWC's database. While the November 2019 list of terms applied reasonably well to Reclamation activities in the Rio Grande Project, when applied to IBWC's database the search generated a large number of documents – over 600,000. For that reason, we created a more exact search with terms that would apply to IBWC's activities within the Project. You agreed during discussions that the new search terms were much better, but declined to accept them. When we ran that "better" search, we identified approximately 7,000 documents to produce.

After New Mexico rejected that search outcome, you then insisted we run the original list with modifications. We worked cooperatively with you to modify the list including the combining of search terms and reduction of the rows of search combinations, but we still had a multitude of search terms to process. We then ran your search and produced documents to all parties on July 15. We are currently preparing another production that will likely add another 30-40,000 documents to our initial IBWC production. These documents are all responsive to your modified search list.

Your modified search term list includes changes to the original list that may be a source of much of the large volume of materials. For example, in line 131 of your modified search term list you eliminated "water accounting" and replaced it with "water" within ten words of Mexico. Your change hits on every reference to "International Boundary and Water Commission United States and Mexico" a reference the agency uses in most of its letterheads and/or communications. These are the types of problems we were seeking to avoid in pursuing the more exacting search of IBWC's database and the use of more refined limiters.



In any event, because these documents are all responsive to your modified search term list and produced upon your request, we don't understand why it is an "enormous problem" for New Mexico, particularly when you can search the documents (with or without the terms and limiters we suggested), and identify documents you may find useful. Lee and Jim:

I was very surprised to see that the United States produced almost 30,000 IBWC ESI documents, as stated in the notice attached below. As you know, because they were produced in a ZIP file to the <u>Box.com</u> system, I cannot even take a look at them until they have been unzipped and are in Veritext, so I won't be able to get a sense of them for at least a day, nor start review of them until they are then also downloaded into the New Mexico platform.

My reasonable expectation was that the United States would produce some 2-3000 documents, given all the negotiations over the few weeks to accommodate the United States' complaints about this group of documents, and given that the United States has had over a year to get this production out.

Thirty thousand documents presents an enormous problem for New Mexico to review, digest, and prepare for any necessary discovery as to the facts in these documents, not to mention mining them for information for the four pending depositions I have requested of the United States.

I suggest a telephone call to discuss solutions. Shelly

## Colleagues:

I will be prepared to discuss this on Friday, but I wanted to give you my viewpoint in advance for your consideration.

It was my understanding that we reached the "final" search term list with the understanding that if we had to deal with anomalies we would do so as we analyzed our hit results and adjust, in good faith, as necessary. The goal being to get out the documents pursuant to our agreements as quickly as possible. New Mexico has made many adjustments to the search terms based on problems we have run into. For example:

 Our technology sees "new" as a blank word (like "the" or "of") so we didn't use it but simply the term "Mexico", which drew up New Mexico and Mexico documents.

- a. Same problem for the term "new well"; we are pulling "well" and applying "new" as a document reviewer search term. You can imagine how many documents we are having to deal with based on this issue.
- 2. My search term list, and the original, has "Groundwater Conservation District"; however, the only use of the term "conserve!" I see in the list provided by the U.S. is "Middle Rio Grande Conservancy" (which in any event I thought was a "do not include" term). John Longworth and other agency custodians have at various times been part of the "Water Use and Conservation Bureau", and "conserve!) was pulling thousands of documents based on their signature line. We wired around that.
- 3. We also combined some searches where the pull was showing redundancies that could be eliminated by combinations (without losing any of the documents pulled by separate

Those are just a few examples out of many decisions we made. With the modifications we made, none impacting the intended "pull" by the parties, we will still have over 450,00 documents, which we are producing on a rolling basis and consider it imperative to get them to you as quickly as possible. We, in turn, need the other parties' documents as quickly as possible.

If I have to go over the U.S.'s search term list as supplied by Lee, compare it line by line to the original list and then the list New Mexico is using, I will have to do so after the depositions of the New Mexico's experts are completed, and I'm sure you are all running into the same time and resource constraints.

What I had understood previously, and may have been mistaken, is that we would do what we needed to do within the confines of our (ethical) obligations to the parties and in light of our agreements, to pull the documents as quickly as possible and deal with the anomalies after the fact. I look forward to discussing if this meets with your recollection and what else we can do to make this massive undertaking as painless (!) as possible.

For your review, I have attached the 2-stage search term list New Mexico is using.

Theresa – Having received large numbers of documents from our search of BOR and IBWC databases, we are finally nearing the end of the production of Reclamation ESI. Thus far, we have produced 68,318 of documents from Reclamation's files. This includes 42,209 documents originally produced after discovery was initiated, and 26,209 documents produced as a result of the ESI search. We currently have 18,670 ESI docs ready to be produced and they should go out the door this week. We still have approximately 10,500 ESI documents under review and we should complete the review and final production of the BOR documents by the 31st. In addition, we have produced 15,848 documents from our initial search of IBWC files. The production of ESI from IBWC will take longer. We do not have a target date for IBWC ESI final production, but we will be rolling out those documents as our batch reviews are completed. Lee

Can you give me an estimate of how many docs we need to be prepared for as we have to shift resources in order to timely complete our discovery given this late production, thanks.

Finally, I am trying to locate the email that accompanied the November ESI list of corrected search terms. As you may recall, the original list had numerous spelling and search syntax errors that rendered the original largely inoperative.

Shelly – We've completed the review of your latest list and we are dismayed by what we've discovered. Almost all of your search strings include new search terms or parameters that were never agreed to in our June 2019 list or the corrected November 2019 list. I repeat my request that you provide the email transmitting the changed November 2019 list; unfortunately, we have no record of that new search term list. If I am mistaken, I will modify my position accordingly. I don't believe it is true that I have added "new search terms"; I have combined many of the previously-agreed terms so as to cut down the number of searches. Please provide examples of where I have added new terms. We don't mind including new search terms that correct or help to better define the original list, but we do object to an expansion at this late date. Please provide examples so that we may discuss. I am not aware of new terms.

Nevertheless, we are willing to proceed with your new terms and searches with the exception of a few search strings that are clearly over-broad and generating large numbers of hits which are likely to be non-responsive materials. For example, you have added an OR term with "District" to the following search string: "El Paso" OR EP* OR District w/10 (use OR well OR groundwater OR contract OR pump OR drill OR acre* OR allo* OR crop OR deliver* OR diver* OR drain OR flow OR gage OR "return flow" OR "water accounting"). I added "District" to capture where the mere acronym of the District might not catch the document, and it seemed easier for you than writing out the entire District name. As long as "Elephant" and "EP*" and "El Paso" is included where capturing the District is included in the search, you may delete "District." You may not be aware that IBWC deals regularly with several irrigation districts in south Texas along our southern border. Consequently, your new search string yields inordinate number of hits likely to be non-responsive.

There are five other search strings that are especially problematic (see comments below). We will proceed with the remainder of your new and modified search terms, <mark>Disagree that there are any new terms; I have combined</mark> previously-agreed terms to reduce the number of searches for your benefit. but the six search strings below are unreasonable and must be changed.
