PER CURIAM.

Dontae Burrage entered a conditional guilty plea to unlawful possession of a firearm as a felon. *See* 18 U.S.C. § 922(g)(1); Fed. R. Crim. P. 11(a)(2). He appeals

an order of the district court* denying his motion to dismiss the indictment. Burrage argues that 18 U.S.C. § 922(g)(1) is unconstitutional on its face and as applied to him as contrary to the Second Amendment. These contentions are foreclosed by circuit precedent. *United States v. Torres*, No. 25-1589, 2026 WL 2472485, at *2 (8th Cir. Aug. 24, 2026); *United States v. Wako*, 182 F.4th 766, 769-70 (8th Cir. 2026); *United States v. Jackson*, 110 F.4th 1120, 1125-26 (8th Cir. 2024), *cert. denied*, 145 S. Ct. 2708 (2025).

The judgment of the district court is affirmed.
